### Letter of Undertaking

I, ..... hereby declare that I am aware of the guidelines provided by the Department of IT, SOT, NEHU, Shillong for the B.Tech (IT) Lateral Entry Admission, 2020. I understand that in case of provisional selection in B.Tech (IT) Lateral Entry program, my candidature against the seat will be valid only after producing the following documents:

- i. Pass certificate and Mark sheets/grade cards (with appropriate conversion formula to calculate equivalent percentage, otherwise NEHU conversion formula will be adopted) of Degree / Diploma in relevant discipline, satisfying the eligibility criteria. The eligibility criteria is given below:

3 year Diploma in Engineering in the relevant branches of IT/CSE/Electronics & Communication Engineering (ECE) with a minimum of 60% mark in aggregate from any recognized institution through study after class 10/SSLC examination OR B.Sc. in Electronics/IT/Computer Science/Mathematics/Physics having secured a minimum of 60% marks in aggregate from any recognized institution having Mathematics at 10 + 2 level. Mathematics must be compulsory subject in B.Sc.(Hons.) level Or BCA having secured a minimum of 60% marks in aggregate from any recognized institution having Mathematics at 10+2 level.

- ii. Pass certificates and Mark sheets/grade cards of all board/council examinations starting from HSLC or equivalent.
- iii. Valid certificate for SC/ST issued by Deputy Commissioner (DC) or competent authority under the seal of DC's office only.
- iv. Permanent Resident Certificate for those who are claiming the permanent resident of Meghalaya.
- v. Date of Birth Certificate or equivalent.
- vi. Employment certificate issued from Registrar's Office, NEHU (for NEHU Ward only).
- vii. Valid certificate for Person with Disability (PH Category Candidates).
- viii. Valid EWS certificate in case of EWS category.

In case, if I fail to produce any of the above mentioned relevant documents in original at the time of admission, my claim against the seat will be invalidated. Further, if any of the above mentioned documents found to be different from the scanned copy sent by me through email, my admission to the department shall be forfeited.
