1. The paper must be in MS Word format and should be submitted online on the e-mail id – nehulawjournal@gmail.com with a copy to hodlaw@nehu.ac.in on or before 15th March, 2018.
2. All contributions must be original and unpublished.
3. The length of the paper, including abstract and references should be between 5000-8000 words.
4. Each paper must be preceded by an abstract within 250 words. Four to Five keywords are required to be specified.
5. Normal margins (2.54 cms) on all sides are to be followed.
Font for the text of the articles – Times New Roman size 12
Font for footnotes – Times New Roman size 10
Font for Heading/Topic – Times New Roman size 14 (bold)
In-text headings - Times New Roman size 12 (bold)

RULES OF FOOTNOTING

The following pattern of footnoting is required to be followed by contributors of articles, notes and comments in the NEHU Law Journal.

1. Mode of Citation for Books

(i) For an authored book

(a) By a single author:

Name of the author, *Title of the book* p.no. (if referring to specific page or pages) (Publisher, Place of publication, edition/year of publication).

E.g. I.P. Massey, *Administrative Law* 127 (Eastern Book Company, Lucknow, 5th edn., 2001).

(b) By two authors:

Name of the authors, *Title of the book* p.no. (if referring to specific page or pages) (Publisher, Place of publication, edition/year of publication).

E.g. M.P.Jain and S.N. Jain, *Principles of Administrative Law* 38 (Wadhawa, Nagpur, 2001)

(c) By multiple authors (more than two):

Name of the first two authors, *et.al.*, *Title of the book* p.no. (if referring to specific page or pages) (Publisher, Place of publication, edition/year of publication).

E.g. Maneka Gandhi, Ozair Husain, *et.al.*, *Animal Laws of India* 94 (Universal, New Delhi, 3rd edn., 2006).

(ii) For Edited Books

(a) By a single editor:

Name of the editor (ed.), *Title of the book* p.no. (if referring to specific page or pages) (Publisher, Place of publication, edn/year).

E.g. David Ormerod (ed.), *Smith and Hogan's Criminal Law* 215 (Oxford, New York, 13th edn., 2011).

(b) By two editors:

Name of the editors (eds.), *Title of the book* p.no. (if referring to specific page or pages) (Publisher, Place of publication, edn/year).

Name of the editors, the first two only, *et.al.* (eds.), *Title of the book* p.no. (if referring to specific page or pages) (Publisher, Place of publication, edn/year).
E.g. Chatrapati Singh, P.K. Coudhary, *et.al.* (eds.), *Towards Energy Conservation Law* 78 (ILI, Delhi, 1989).

(d) By, or on auspices of, an organization/institution:

World Health Organization, *Research for Universal Health Coverage: The World Health Report* (WHO, Geneva, 2013)

2. Mode of Citation for Articles/Essays

(a) Citation of a paper published in a journal/periodical:

E.g. K. Madhusudhana Rao, "Authority to Recommend President's Rule under Article 356 of the Constitution" 46 *JILI* 125 (2004).
E.g. Charles Fried, "Privacy", *The Yale Law Journal*, Vol.77, No.3 (Jan., 1968), pp. 475-493, 480.

(b) Citation of a paper published in a case reporter:

E.g. M.P. Singh, "Are Articles 16(4) or 15(4) Fundamental Rights?" (1994) 3 *SCC (Jour)* 31-41, 35.

(c) Citation of an essay published in a book edited:

Name of author of the essay, title of the essay within inverted commas, in Name of the editor(s), *title of the edited book* page number (publisher, edition/year). E.g. R.K. Nayak, "Evolving Global Drugs Law for the 21 st Century" in D.C. Jayasuriya, R.K. Nayak *et.al.*(eds.), *Global Drugs Law* 70 (1997).

(d) Citation of a writeup published in a newspaper/periodical:

Name of the writer, Title of the write-up within inverted commas, Name of the newspaper, date.

E.g. Abheek Barman, "A Secret History of Maps: Why the Geospatial Bill is an Outcome of Sarkari Cartographic Paranoia", *The Times of India*, May 18, 2016.

(e) Citation of an editorial from a newspaper:

Editorial, Title of the Editorial within inverted commas *Name of the newspaper*, date.

E.g. Editorial, "Anti-defamation" *The Shillong Times*, May 17, 2016.

(f) Citation of a reference from an Encyclopaedia:

Edwin R.A. Seligman (ed.), XV *Encyclopaedia of the Social Sciences* (The Macmillan Co., NY, 1957).
