 - IV. Phone no.
 - V. Trading License (as applicable)
 - VI. Up-to-date Sales Tax clearance certificate/ GST registration certificate indicating also the TIN number will have to accompany the quotation to be submitted.
 - VII. Amount of Earnest Money Deposit (EMD) in the form of Demand Draft only will have to be clearly stated and the same will have to be enclosed.
 - VIII. Income TAX/sales TAX clearance certificate.
 - IX. In the part of relating to Price Bid, the vendor must provide the following;
 - a) Basic price (against item wise details of specifications of each of the offered items)
 - b) Packing & Forwarding charges, if any (as percentage of basic price as lump sum)
 - c) Central/State Sales Tax/GST (as percentage of basic price + Packing & forwarding charges if any)
 - d) Freight & insurance charges, if any (as percentage of a+b+c or lump sum)
3. Sealed envelope containing quotations dully super scribing "QUOTATION FOR SUPPLY OF MATERIALS FOR MBA ROAD" should be addressed to Pro-Vice Chancellor, NEHU, Tura Campus, Tura-794002 and should reach the undersigned on or before **25.03.2019**
4. The quotation will be opened **on 25.03.2019 at 3.00pm.** in the office of the Pro-Vice Chancellor NEHU, Tura Campus. In case if the date for receiving and opening of tenders is subsequently declared holiday(s), the tender will be opened on the next working day following the holiday. However, opening/closing of tender the same.
5. The quotation should be accompanied with Earnest Money of Rs. 5000/- (Rupees Five Thousand)(RESUNDABLE)only in the form of DD/Banker cheque issued by State Bank of India in favor

of NEHU, Tura Campus, Tura. Tender not accompanied by the prescribed Earnest Money will be summarily rejected.

6. The rate quoted for specific brand/quality/ item etc should be inclusive of all taxes packing and transportation and delivery charges to NEHU, Tura campus, Chasingre, Tura
7. Only one rate should be quoted against a particular item/ brand. No overwriting/overtyping/erasures in the quoted against any items will be rejected summarily.
8. The rate quoted and accepted shall remain unchanged for a period of 90days year.
9. All items to be supplied should be as per specification submitted by the firm.
10. Incomplete information submitted by tendered are liable to be rejected.
11. Any dispute arising out of this purchase shall be referred to the Pro-Vice Chancellor, NEHU, Tura Campus, and if either of the parties hereto is dissatisfied with the decision the dispute shall be referred to the decision of an Arbitrator, who should be acceptable to both the parties to be appointed by the PVC. The decision of such Arbitrator shall be final and binding on both the parties.
12. The acceptance of the quotation will rest solely with the PVC, NEHU, Tura Campus, who in the interest of the University is not bound to accept the lowest quotation and reserves the right to himself to reject or partially accept any or all the quotations received without assigning any reasons. Any dispute arising out of this purchase shall be referred to the Pro-Vice Chancellor, NEHU, Tura Campus, and if either of the parties hereto is dissatisfied with the decision the dispute shall be referred to the decision of an Arbitrator, who should be acceptable to both the parties to be appointed by the PVC. The decision of such Arbitrator shall be final and binding on both the parties.
13. The contract shall be governed by and construal according to the laws in forced in India. That, any matters of disputes arising out of contract agreement will be subject to jurisdiction of the Courts located at Tura, Meghalaya.
14. Quotationers should quote their rates in the given Performa, only.
15. Joint ventures are not accepted.
16. No escalation, extension of time and advance for the work will be granted unless specifically approved by the competent authority.
17. The University reserves the right not necessarily to accept the rate of the lowest quotation and may reject any or all the quotations without assigning any reason thereof.
18. The payment for the supply shall be made by the finance Department of the University. After cross checked by the engineering cell of the University.
19. Please note that near relatives of the officer or staff of NEHU are not allowed to participate in the tender. In case it is found so, the tender of such tendered will be disqualified. The term 'relative 'for this purpose would be as who are not near relatives of University Engineer/ Divisional Accountant or Superintending Engineer or Executive Engineer/ Assistant Engineer/ Junior Engineer of the University.

NOTE:- a near relative means wife, husband, parents, in-laws, children, brothers, sisters, uncles, aunts and cousins.
