1. Admission into B.A.LL.B (Hons.) Programme for **Open Category** & Supernumerary seat for **NEHU Ward** will be held on 13 & 14 September, 2021 (Monday & Tuesday) at the Dept. of Law from 10:00 AM to 1:00 PM.
2. Admission into B.A. LL.B (Hons.) Programme for Waiting List **Open Category & Waiting List NEHU Ward** will be held on 15 September, 2021 (Wednesday) at the Dept. of Law from 10:00 AM to 1:00 PM.
3. Admission into B.A. LL.B (Hons.) Programme for **Reserve Category (SC/ST)** will be held on 16 & 17 September (Thursday & Friday) at the Dept. of Law from 10:00 AM to 1:00 PM.
4. Admission into B.A. LL.B (Hons.) Programme Waiting List **Reserve Category (SC/ST)** will be held on 20 September, 2021 (Monday) at the Dept. of Law from 10:00 AM to 1:00 PM.
5. Admission into B.A. LL.B (Hons.) Programme for **EWS Category (7 seats)** from General category of candidates on the basis of merit and subject to submission of EWS certificate from competent authority and other relevant documents will be held on 21 September, 2021 (Tuesday) at the Dept. of Law from 10:00 AM to 1:00 PM.
6. Admission into B.A. LL.B (Hons.) Programme for waiting list **EWS Category** from General category of candidates on the basis of merit and subject to submission of EWS certificate from competent authority and other relevant documents will be held on 23 September, 2021 (Thursday) at the Dept. of Law from 10:00 AM to 1:00 PM.
7. The B.A. LL.B (Hons.) classes for first Semester will start from 27th September, 2021 (Monday) at 10:00 AM through online mode.

1. Candidates failing to turn up for admission on the specified dates will forfeit their chance and the seat will be allotted to the next candidate in the order of merit. Any canvassing in this regard will not be entertained under any circumstances.
2. Candidates seeking admission into the B.A. LL.B (Hons.) Programme must produce the following documents in original for verification:

 - (ii) Four passport size photographs
 - (iii) Matriculation Certificate (Class X) & Marksheet
 - (iv) Higher Secondary (+2) Marksheet & Certificate
 - (v) Birth Certificate
 - (vi) SC/ST/PH/NEHU Employees' Ward/EBA/Ex- Servicemen Wards' Certificate/EWS Certificate etc. (claimed if any)
 - (vii) Transfer Certificate/ Migration Certificate
 - (viii) Character/Conduct Certificate issued by the Head of the Institution last attended
 - (ix) Photo copies of documents not submitted along with the application form
 - (x) Admission fee, semester fees & other University fees. Hostel admission fees in case of candidates seeking accommodation in hostels. (Approximately Rs. 20,000/- to be paid online).
