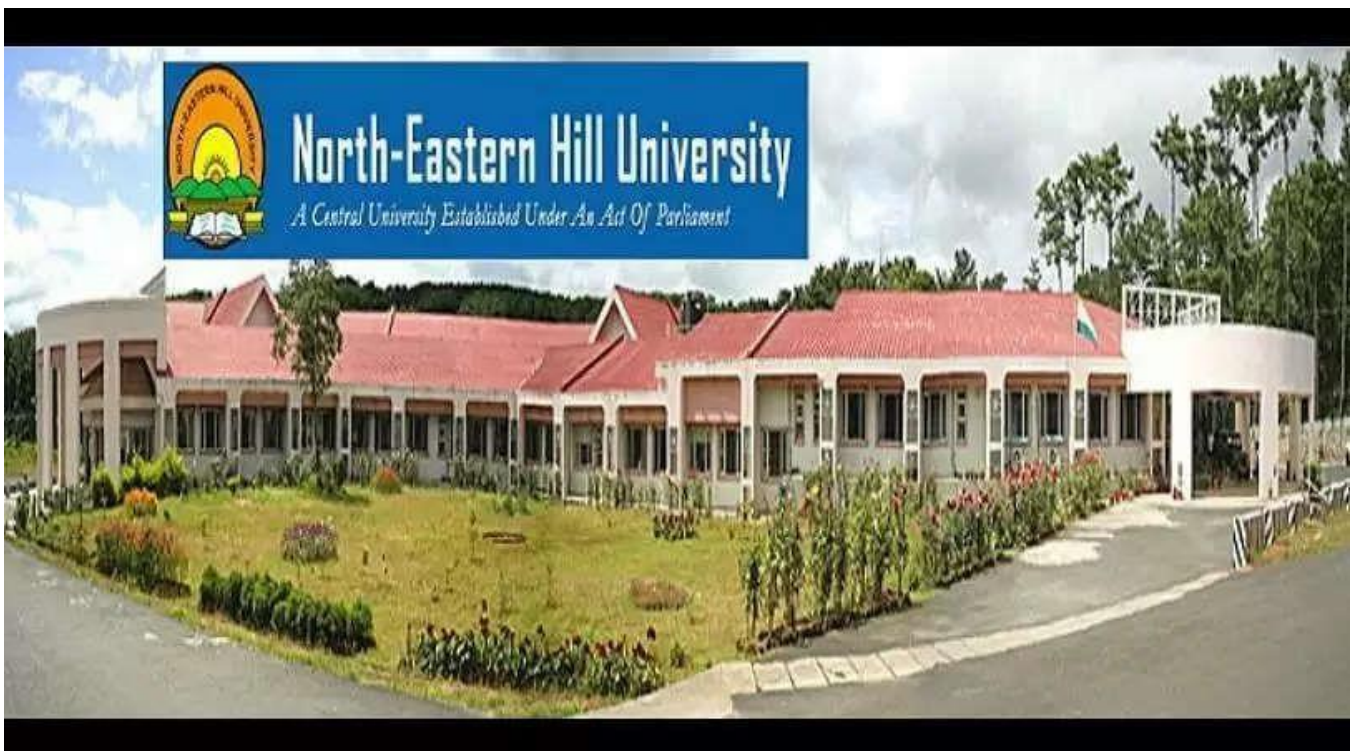

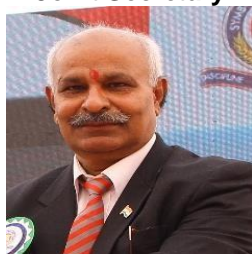

About the Conference

The 'Azadi Ka Amrit Mahotsav' is an embodiment of all that is progressive about India's socio-cultural, political, and economic identity. It is also an initiative to celebrate and commemorate 75 years of progressive independent India and the glorious history of its people, culture, and achievements.

India is historically known as "Soni ki chidiya". In the early 18th century, it represented around 25 % of the world's total industrial output. With such a rich and glorious legacy Prime Minister Shri Narendra Modi led NDA government re-envisaged the vision of the golden bird in the form of India 2.0 via two strategic campaigns – "Atmanirbhar Bharat Abhiyan" and "Be Vocal for Local". The Atmanirbhar Bharat Abhiyan (ANBA) is a pathway toward the idea of self – reliant (although not an isolation) economy. Land, Labor, Liquidity, and Laws are its main focal points which would hinge on five central pillars- Economy, Infrastructure, Technology Driven System, Vibrant Demography, and Demand. The ANBA started with broader objectives- import substitution, focus on quality to gain global market share, strengthening local markets along with improvement in production and supply chain management, with the intention to encourage/boost the manufacturing sector in India and thereby providing economic relief to its main proclaimed chief beneficiaries viz. labourers, farmers, honest taxpayers, MSMEs, and cottage industries.

Moreover, the Atmanirbhar Bharat Abhiyan package involves promoting local manufacturing, the government facilitated structural reforms such as the redefinition of public sector undertakings, One Nation One Ration Card initiative, and production-linked incentive schemes. Towards this direction, the Department of Economics, North-Eastern Hill University, Shillong intends to provide a platform in its 3-Day Conference to the academia, researchers, practitioners, and experts from multi-disciplinary interests for scholarly discussion and meaningful discourse on the various issues of contemporary importance toward the achievement of vision 2.0. While the eloquence and intention behind the novel vision of India 2.0 are certainly laudable but the need of the hour is to have a critical and comprehensive analysis of policy measures that have been taken and would be taken, so that its goals and desired targets are fulfilled without fail, for which this platform would be the best one. With this viewpoint, the themes and sub-themes are accordingly framed.

Moreover, given the historical, cultural, political and economic importance of North Eastern region of India with the huge untapped potential of agro-based industries, handloom and handicrafts industries, carpet and wood-craft industries, tourism, creative art and hospitality industry, etc., this platform will comprehensively layout the future pathway to explore the potential and eco-friendly sectors for low cost and high return investment projects for sustainable and equitable growth and development of the states, and hence, the Indian economy. The North-Eastern Hill University (NEHU)

North-Eastern Hill University (NEHU) is a Central University in the suburb of Shillong, the state capital of Meghalaya, India which was established on 19 July 1973 by an Act of the Indian Parliament. The objectives of the University, as laid down in the act, are "to disseminate and advance knowledge by providing instructional and research facilities in such branches of learning as it may deem fit; to pay special attention to the improvement of the social and economic conditions and

welfare of the people of the hill areas of the North-eastern region, and in particular, the intellectual, academic and cultural advancement".

NEHU has three campuses, with the main campus located at Mawkynroh-Umshing, Shillong, and the other two campuses located at Tura and Jowai. NEHU has established itself as an institution of higher learning and research with 44 departments and two centres of study under a total of eight schools offering courses across Law, Management, Computer Applications and various other streams. There are 79 colleges affiliated to NEHU offering UG, PG, PhD and various other courses to students. It has been able to attract persons of proven academic excellence from almost all parts of the country to serve in its faculty; and its student community is drawn not only from the different parts of North-East but also from other parts of the country. The university also offers placement assistance to students and student exchange programmes.

The Department of Economics

Established in 1974, the Department of Economics is one of the oldest and largest Departments of NEHU. The Department ranks admirably among the Indian Institutions of higher learning as per the ranking of IDEAS/ RePEc, a global electronic archive of working papers and publication in Economics, Econometrics / Statistics and Finance maintained/ hosted by the Department of Economics, University of Connecticut/Federal Reserve Bank of St. Louis, USA. The department offers Masters Degree and PhD programme in Economics. Some of the important areas where the department has established its research competence are: (i) Rural Economics and Rural Development, (ii) Human Development, (iii) Environmental Economics, Environment and Economic development, (iv) Economics of Health and Education, (v) Economics of Poverty, (vi) Fiscal Economics, (vii) Economics of Microfinance and SHGs, (viii) Financial Economics and (ix) Urban Informal Sector. The M.A./M.Sc. Syllabus of the department has been updated both in content and context in line with the NEP. As an equal opportunity department, it has zero tolerance policy on matters of any kind of harassment to the students and faculty.

Faculty members of the department, in addition to teaching and research, have also been regularly providing critical policy support to the central, state and local governments on issues and programmes of economic development. Many of the faculty members have worked and are working as members of different committees of central, state and local bodies and have undertaken research projects supported and funded by UNDP, Indian Statistical Institute, Ministry of Rural development (GOI), ICSSR, Institute of Dalit Studies, Government of Meghalaya, State bank of India, V.V. HOW TO REACH SHILLONG

Shillong is well connected by air, railways and road network

ByAir

The only airport in Meghalaya is located at Umroi which is about 38 kms from Shillong. One can take a bus or a taxi to their preferred destination. The major airport to Shillong is located in Guwahati, about 128 kms from Shillong. Shared taxis are available outside the airport.

ByTrain

The nearest rail head to Shillong is Guwahati, about 108 kms from Shillong city. To reach Shillong, one can opt for buses or a shared taxi near the railway station. Prefer taxi, as it will drop you at NEHU campus.

Road/Self Drive

Shillong is well connected by road. State transport buses and taxis are available, Delegates from nearby areas can also drive to NEHU.

Note: Suggested take flight to Guwahati and the hire a taxi directly for NEHU, Shillong

What you will need to carry on your visit

1. Winter clothing as it gets chilly during the month of November.
2. Umbrella as the weather can be unpredictable with possible light shower.
3. Comfortable shoes and clothing if one enjoys nature and the outdoors.

Weather in Shillong:

Shillong weather remains pleasant throughout the year with temperature ranging between 15⁰C to 26⁰C during summer to about 5⁰C during winter season.







