- iii. The institution shall maintain the required endowment and reserve fund converted in the joint operation in the name of institution and regional Director of the concerned Regional Committee as per clause 7(16) of NCTE Regulations 2014.*

*4. Further, admissions shall not be made until Recognition Order under Regulations 7(16) of the NCTE (Recognition Norms and Procedure) Regulations, 2014 is issued by the **Eastern Regional Committee, NCTE** and thereafter obtaining the affiliation from the concerned affiliating body.*
