- 7. That the copy of the affidavit shall be displayed on the website of the institution for general public.
- 8. I have been authorised by the Management of the above mentioned institution to give this Affidavit on behalf of the institution, which at present offers M.Ed course of 2 (Two) year duration (File Code No. F. ERC/NCTE/ERCAPP1974/M.Ed (Revised Order)/2015/31780 dated 20/05/2015 with an annual intake of 50 (Fifty for One Unit). It is further certified that the management has studied the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2014 carefully and has understood their implications for the existing Teacher Education Institutions offering NCTE recognized teacher education programme(s).
