NOTIFICATION

With a view to control the spread of the Covid-19 (Corona virus) and in continuation of the Notification No. 28-6/Acad/AC/2019/262 dated 23rd March, 2020, it is further to notify that :

- (i) All the employees both Teaching and Non-Teaching, their family members, Dependents, Students, Research Scholars staying in the Campus and have undertaken any journey outside Meghalaya with effect from 1st March, 2020 onwards, must register themselves in the office of the Deputy Commissioner, Shillong and/or call 108 or register online http://meghalayaonline.govt.in/covid. If anyone is found violating/flouting/suppressing these facts and not getting registered with the D.C. office, Shillong, the University Administration shall be constrained to inform the Law and Order machinery of the State for the needful action.
- (ii) From now onwards and until further order, the Gate No. 4 of the NEHU Campus shall remain closed for all vehicular movement except for the movement of pedestrians. All vehicular movement shall be only through Gate No.2. However, no vehicle be allowed to move through Gate No.2 during the time of curfew except on medical emergencies.
